Update on quarantine regulation at 'Chittagong Port' during Coronavirus outbreak

Dear Valued Customer,

Please be informed that Chittagong Port Authority (CPA) published an '**Emergency Circular**' on 24th March and set 14 days quarantine period for all the vessels and the counting will start from the departure date of the last port [annex – 1].

But considering the adverse impact on overall trade in Bangladesh, CPA published '**Cancellation of Emergency Circular**' on the same day and ensured that the presiding is no more applicable [annex – 2].
