Refreshment of MLO SOC (Shipper Own Container) Booking procedure

In this regard, we would take an opportunity have a refreshment on the Deadline for SOC unit(s) in order to align understanding and make sure vessel/containers can be plan properly.

It is mandatory requirement for customer to provide **final SOC container gate in list within 16:00hrs, on one day before vessel's arrival (excluded holidays/weekend).**

Delayed final gate in list provided after deadline and amendment/additional to final gate in list might result to rejection ED (Export Declaration file) submission and deny loading of your shipment(s) as consequences.

Following table is a summary of all the closing time related to export shipments.
This cut-off time will help you to manage your shipment according to planned schedule.
