Sr. No.	Booking Amendment	Description	Fee Details
7	Equipment size/type change	Merchant requests to change equipment size/type, irrespective whether this result in change of total TEU in booking.	Subject to repricing of the amended equipment. And Cancellation Fee for the equipment size/type removed from the booking applies if the changes is provided seven (7) days or more prior to estimated time of departure of the original first leg ocean going vessel. Or No Show Fee for equipment size/type removed from the booking applies if the change is provided less than seven (7) days prior to Estimated date of departure of the original first ocean leg going vessel.
8	Equipment addition resulting in total TEU increasing	Merchant requests to add same size/type equipment, which increases the booking total TEU	Subject to new price for added equipment.
