For containers arriving via Tallinn special confirmation must be received from [ESTOPS@maersk.com](mailto:ESTOPS@maersk.com) prior to containers gate out.

For containers arriving via Riga special confirmation must be received from [LATOPS@maersk.com](mailto:LATOPS@maersk.com) prior to containers gate out.

For containers arriving via Klaipeda special confirmation must be received from [LITOPS@maersk.com](mailto:LITOPS@maersk.com) prior to containers gate out.

Terms:

1. For Containers discharged in Baltic ports Railway Bill with Russian customs stamp for border crossing may be required. It should be provided within 1 working day upon request, otherwise all related charges to be invoiced to Customer.
2. Drop-off tariff application date – container gate in date at the origin country.
3. Drop-off instructions must be requested in import department prior to containers gate-out date. Please advise the preferred depot of the drop-off in the initial request.
4. Fine of USD 300 is applicable for containers which are dropped without Line instructions.
5. VAT (Russian) not applicable.
6. 5% commission applies in case payment in RUR
7. In case of empty containers are positioned from other rail station to above depots by railway, additional charge of 150 USD per container is applied. They are to cover extra expenses for empty acceptance and trucking to the depot. Charge is not applied in case Customer pays for mentioned services directly to the local agency.
8. Line will issue all related costs (trucking to the repair station etc) to the GD User in case when depot won't be able to fix cntr damage locally.
9. Acceptance of containers is subject to prior confirmation from equipment department.
