## **Mandatory Usage Bullet Seals for All Import Laden Containers to Bangladesh**

Dear Valued Customer,

With reference to the Circular: 17/2021 dated 27-Oct-2021, kindly be informed that Chittagong Port Authority (CPA) has urged to stop using plastic/metallic seals going forward and advised to use '**Bullet Seal**' for all import laden containers to be handled through Port of Chittagong. In the same circular, CPA has also specified their stance of refusing the discharge of any import laden containers found without Bullet Seal affixed. Hence, we request all our customers to inform your valued exporter/shippers/booking agents to comply with this instruction and mandatorily affix Bullet Seal on the containers. For further details – kindly refer to the circular is attached with this advisory.

For any confusion or query, please reach out to our local office at port of loading, who will provide necessary guidance and assistance in this regard.

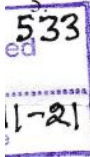

SUB:- USING OF BULLET SEALS IN LADEN IMPORT CONTAINERS SHIPPED FOR CHITTAGONG.

1. IT is observed that most of the laden import containers handled at Chittagong port bear the original plastic /metal strip security seals which being brittle and frail, get easily broken exposing the contents thereof to the risks of damage or loss, much to the worry and inconvenience of the parties consumed.
2. "Bullet" seals, on the other hand, are found to better, convenient and durable. With the necessity of ensuring the security of the cargo of such boxes against any possible loss or damage, it has been decided that "Bullet" seals instead of Plastic/Metallic steel ones are to be used in the laden import containers in future.
3. In view of the above all shipping agents are advised to ensure that "Bullet" seals in lieu of plastic/metallic steel seals are used from the port of origin in all laden import containers to be handled through the port of Chittagong.
4. Chittagong Port Authority may refuse acceptance of loaded import containers without "Bullet" seals on and from 01/12/2021 notwithstanding anything to the contrary notified previously from this end.
